DIRECTIONS FOR USE:

Soluble for Tank Mixing

Greens & Tees - 16 oz (1lb) per acre biweekly, or 8 oz (½lb) per acre weekly.

Fairways - 4 oz (¼lb) per acre monthly.

Lawn - 4 oz (¼lb) per acre every 4 to 6 weeks.

Sports Fields - 8 oz (½lb) per acre monthly.

Flowers & Bedding Plants - 8 oz per 50 gallons water, apply 2 to 3 gallons finished product per 1000 sq. ft.

Transplants - 8 oz per 50 gallons water, apply as a drench.

STORAGE:

Store product in original container with bag tightly secured. Store in a dry area (40° – 110° F | 4° – 44° C) out of direct sunlight.
