When enhancing bulk fertilizer, maintain effective rate of 16 oz to 32 oz per acre or 1.173 L (1,173 mL) to 2.345 L (2,345 mL) per hectare.

### EFFECTIVE RATE

**Starter or Side Dress** – Apply 1 to 2 pints per acre or 1.173 (1,173 mL to 2.345 L (2,345 mL) per hectare. Mix with sufficient volume of water to achieve desired coverage.

**Foliar Application** – Apply 1 to 2 pints per acre or 1.173 (1,173 mL to 2.345 L (2,345 mL) per hectare.

**Broadcast** – 4 pints per acre or 4.693 L (4,693mL) per hectare. Mix with sufficient volume of water achieve desired coverage.
